Notice of Omission Sites Consultation

The District Council is consulting on Omission Sites arising out of the public consultation on the Warwick District Local Plan 1996-2011. Omission Sites comprise land suggested by an objector as an allocation, land where an alternative use to that proposed in the plan is suggested and sites where a material change to the boundary of a site allocated in the plan is suggested.

Objections proposing Omission Sites have been received at first and revised deposit stages and are available for inspection at the Council Offices at Riverside House, Milverton Hill, Royal Leamington Spa, as part of the overall representation documentation for the Local Plan Inquiry. These Omission Sites will be considered through the Inquiry. The final decision as to whether the Omission Sites should be included in the Local Plan will be made by an Independent Inspector, whose report will be binding on the Council.

To help inform the Inspector's decisions, the Council is consulting upon the Omission Sites.
