In accordance with Regulation 19 of the Town & Country Planning (Local Development) (England) Regulations 2004, notice is given that Warwick District Council formally adopted its Affordable Housing Supplementary Planning Document (SPD) on 11 January 2008.

The SPD expands upon Policies SC11 and RAP4 of the Warwick District Local Plan 1996 -2011. These policies are concerned with the requirements for affordable housing on housing development sites and the provision of rural affordable housing.

Please note that at the consultation stage this SPD was entitled Mixed Communities and Affordable Housing.
