In accordance with Regulation 19 of the Town & Country Planning (Local Development) (England) Regulations 2004, notice is given that Warwick District Council formally adopted its Vehicle Parking Standards Supplementary Planning Document (SPD) on 16th November 2007.

The SPD expands upon policy DP8 of the Warwick District Local Plan 1996 – 2011 setting out the Vehicle Parking Standards required for different types of new development.
