Any person aggrieved by the Statement of Community Involvement may make an application to the High Court under Section 113 of the Planning & Compulsory

Purchase Act 2004 on the grounds that the document is not within the appropriate power or that a procedural requirement has not been complied with. Applications should be made within 6 weeks of (adoption date)

Any person aggrieved by the Statement of Community Involvement may apply to the High Court for permission to apply for Judicial Review of the decision to adopt the statement. Any such application must be made promptly and in any event not later than three months from (adoption date).
