### **Property Consultation 2014 – for the London-West Midlands HS2 route**

Dear Mr Elliott

I am writing to let you know that High Speed Two (HS2) Ltd has launched its Property Consultation 2014. We are consulting on two proposed schemes, as the government set out in an announcement in April 2014. These schemes, the **alternative cash offer** and the **homeowner payment**, are summarised in the enclosed factsheet. They would complement the assistance already available – and soon to be introduced – for people near the route of Phase One of the proposed high speed railway, between London and the West Midlands. The existing schemes are also summarised in the factsheet.

The consultation runs until 23.45 on Tuesday 30 September 2014, and it is open to everyone to contribute their views. We would like to ensure that the relevant information is available to people who, because they live close to the line of route, may be interested in taking part. We would be very grateful for your help with this.

This letter explains how to find out more about the proposals and submit a response. Please feel free to share this information with your contacts and stakeholders, post it on your website, or contact us for additional copies of documents.

We are also writing to owner-occupiers of properties within 1km of the line of route in rural areas and 300m in urban areas, to make them aware of this consultation and their opportunity to comment on the proposals.

The enclosed factsheet introduces the two new schemes on which we are consulting, as well as explaining the existing package of measures for people affected by Phase One.
