Publication Draft Local Plan: Focused Consultation

1 Introduction

- 1.1 The Publication Draft Local Plan (April 2014) was published for a six week period of public consultation between Friday 16th May and Friday 27th June 2014. Since then further work has been undertaken to assess the suitability of alternative employment land options within the District. Further, two pieces of evidence that were relied upon in preparing the Publication Draft Local Plan have been published more recently. This consultation therefore covers two areas:
- Proposed amendments to allocations in the Local Plan
 - An opportunity to make further representations on the Local Plan where it is considered the more recently published pieces of evidence have a bearing on it.

2 Proposed Amendments

- 2.1 The Council is proposing that Land at Stratford Road, Warwick is allocated for employment land and that the employment allocation referred to as E1: Land North of Gallows Hill is removed and that this area is allocated for housing and other uses.. A detailed schedule of the proposed changes is set out in Table 1 below and the area of land to be allocated at Stratford Road is shown in the map extracts section at the end of this document.

3 Updated Evidence

- 3.1 Since the consultation on the Publication Draft Local Plan, the Council has now published the Joint Strategic Employment Land Study. An updated version of the Strategic Housing Land Availability Assessment (SHLAA) has also been published to include some changes and additional sites which were omitted at the time of the consultation, the specific document is entitled 'SHLAA Amendments July 2014'.
- 3.2 As these pieces of evidence informed the production of the Publication Draft Local Plan but were not available at the time of the consultation, the Council is allowing further representations to be made on the Local Plan where it is considered these pieces of evidence have a bearing. It is intended to include these documents as "submission documents" for the Local Plan. If you feel you wish to amend your representation to the May /

June 2014 consultation in light of these pieces of evidence or you wish to make a new representation, you may do so as part of this consultation.

4 Consultation Process and Timetable

- 4.1 The Council is undertaking an additional period of Public Consultation on these changes in accordance with Regulation 19 and 20 of the Town and Country Planning (Local Planning) (England) Regulations 2012. This will run from 31st October 2014 to 12th December 2014. Representations received will be analysed by the Council and submitted along with those representations made previously. Full details of the consultation process are set out in the Statement of Representations Procedure.
- 4.2 An area of land in the vicinity of Stratford Road, Warwick is also proposed as a preferred option for a Gypsy and Traveller site. The consultation regarding this use is running concurrently with this consultation and your views are sought on both. Please see our separate consultation document and response form for this topic area.

5 Other amendments to the Publication Draft Local Plan

- 5.1 In addition to the above changes, the Council will publish proposed minor amendments to the Publication Draft Local Plan in response to the consultation undertaken in May and June 2014. These will be submitted with the Plan to the Secretary of State and will be formally published at the time of Submission.

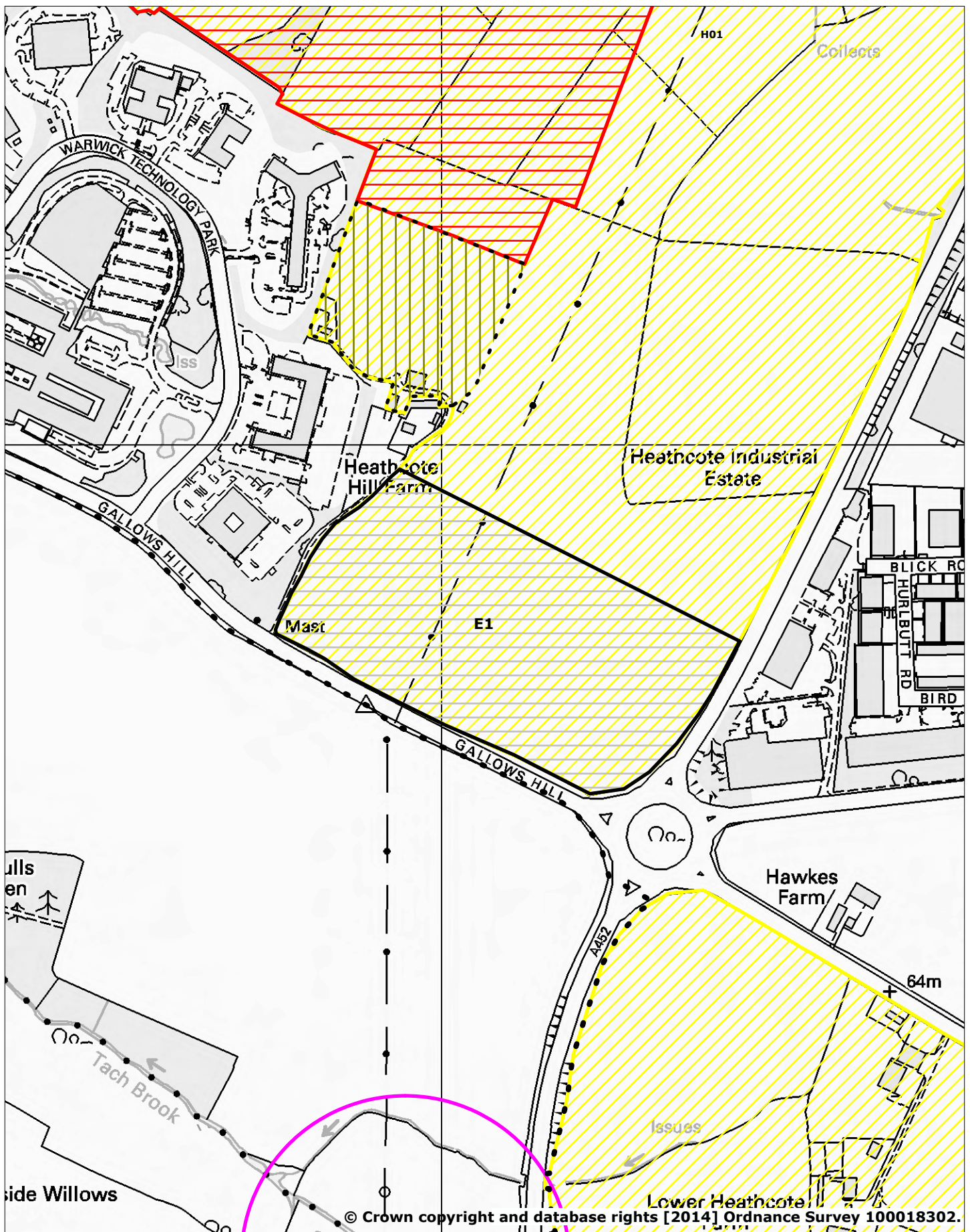

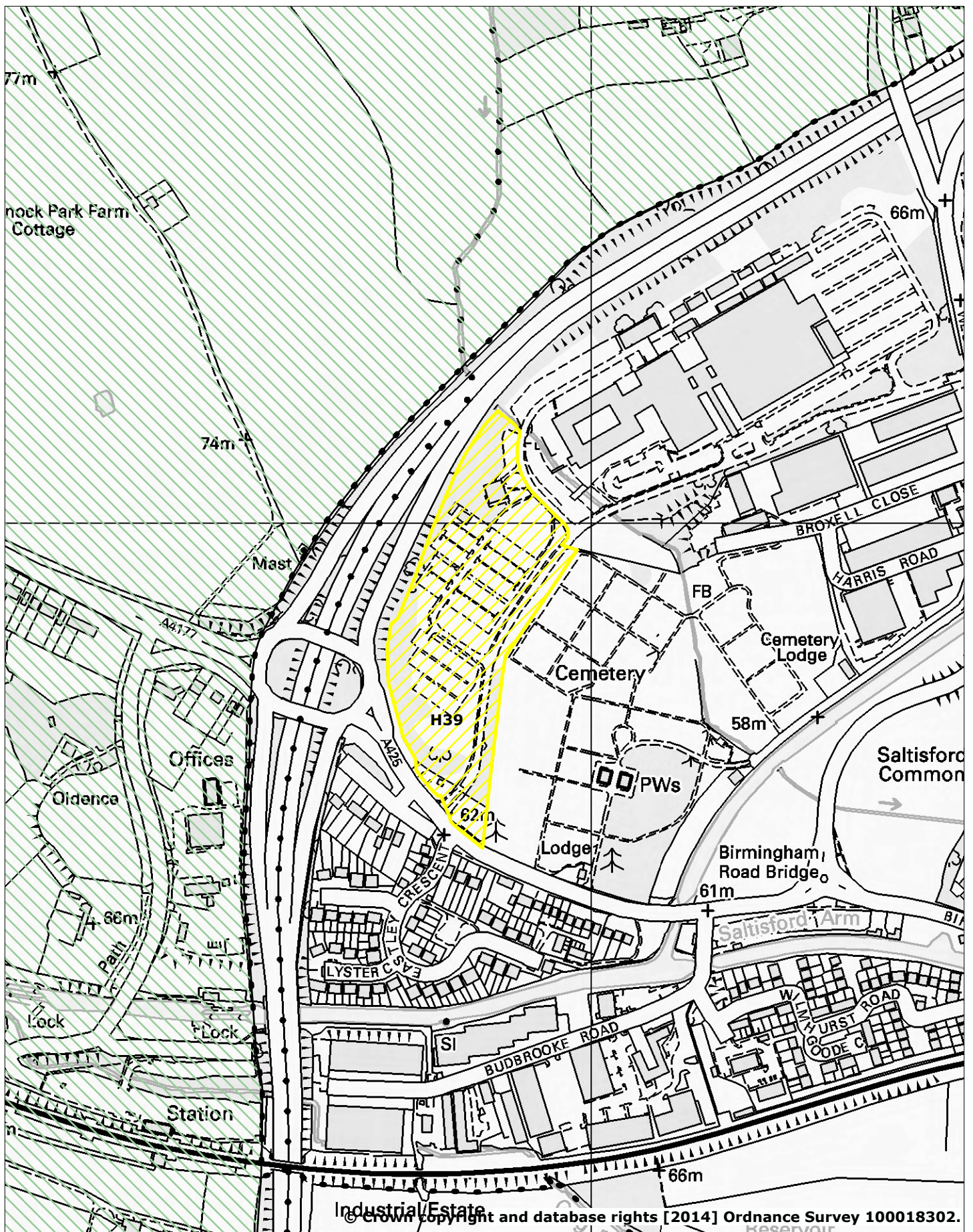

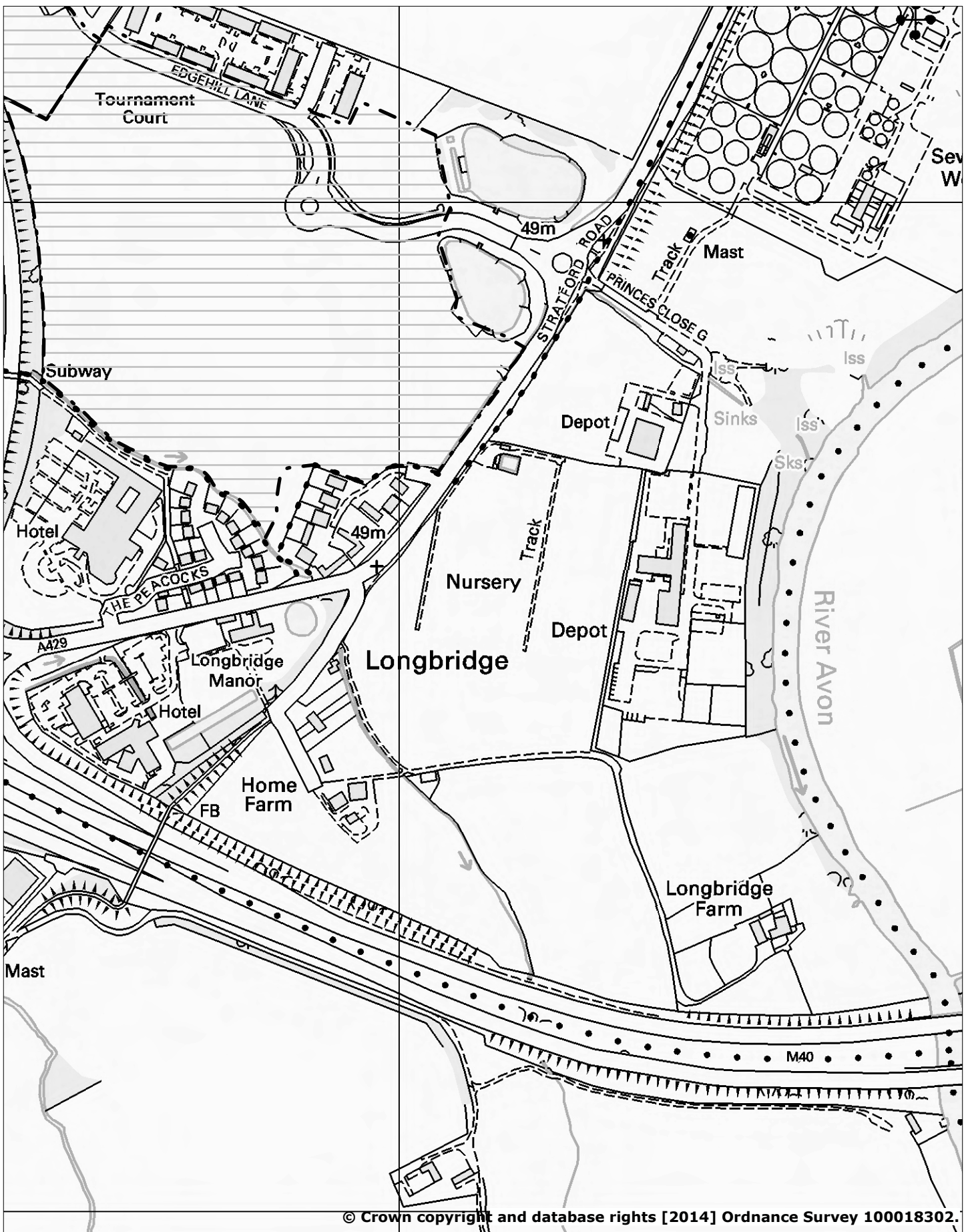
