In response to the Inspector's interim conclusions on the Warwick District Local Plan, which was submitted for public examination on 30 January 2015, Warwick District Council is now consulting on proposed modifications to the Plan in order address the issues of soundness identified in the Inspector's letter dated 1st June 2015.

Period for representations: This consultation on the proposed modifications to the Local Plan and on the draft addendum update to the Sustainability Appraisal/Strategic Environmental Assessment relating to the modifications will run for a period of 6 weeks beginning at 4.00pm on Friday 11 March 2016 until 4.45pm on Friday 22 April 2016.

Making representations: The Modifications are now available for public comment before they are formally submitted to the Inspector and the Examination in Public of the Local Plan will recommence.

All representations received within the six week period together with the proposed modifications and all supporting documents will be submitted to the Inspector for consideration. Representations at this stage must only relate to the main modifications proposed.
