1) Starting point is submitted Local Plan i.e. Publication Draft as amended by Focussed Changes (**not modifications set out in LP21 or in January 2016**)

Main modifications would be to the text of the submitted Local Plan
 Unless referred to below, no modification required for soundness. No other modifications should be added. Minor modifications prior to adoption are entirely a matter for the Council and should be kept entirely separate from this process.

4) Single modification with single ref i.e. MM1 for all bullet points under DS2 etc. which may incorporate a number of specific amendments to a policy or explanatory text.

5) Main Modifications will not relate to the Policies Map as Inspector does not have remit to recommend modifications to it. Where the Policies Map needs to be amended from that in the submitted Local Plan, these amendments should be set out and included in consultation material published as an appendix to assist people. These should include additional sites, deleted sites and amended site boundaries.

- The nature of the heritage asset prevents all reasonable uses of the site; and
- No viable use of the heritage asset itself can be found that will enable its conservation; and

- The harm or loss is outweighed by the benefit of bringing the site back into use.

Where development would lead to less than substantial harm to the significance of a designated heritage asset, this harm will be weighed against the public benefits of the proposal, including securing its optimum viable use."
