You have only applied the 10% buffer to NBBC's OAHN and not to the whole housing target. Total capacity in the Borough is 13,374, equivalent to 12,158 +10% (1216)

Deduct 10,040 NBBC OAHN (12,158 – 10,040) giving 2,118 dwellings we can provide for Coventry.

4,020 Coventry provisional allocation – 2,118 = 1,902.
