

Warwick District Local Plan Examination

Note of differences in calculating housing supply between Warwick District Council and Bishop's Tachbrook Parish Council

1. This note is a summary of action 81, which was requested by the Inspector during Matter 3 hearings:

“WDC to assess differences in housing trajectory, especially commitments and completions, with housing trajectory put forward by Bishops Tachbrook Parish Council”
2. Prior to the Matter 3 hearings the Council produced a note regarding the Parish Council's Matter 3 statement (EXAM 128). In summary (see para. 4) it considered that the differences can be explained due to a number of factors including:
 - a. Different windfall assumptions
 - b. Inclusion of vacant dwellings allowance
 - c. Inclusion of commitments in the current monitoring year (granted post 1st April 2016)
 - d. Differences in calculating supply from HMOs/student accommodation and care homes
3. The Parish Council submitted a response to the above (EXAM 128A) and included a list of sites that it considered WDC had not taken account of at Annexe B. This amounts to a total of 2338 dwellings, either not started or under construction (commitments) or completions. The Council has undertaken an analysis of all sites over 10 units included within Annexe B and considers that the significant majority have been taken account of and are either recorded in the District's Trajectory as completions, commitments, small shlaa sites or allocations (see appendix 1). It should be noted there may in some instances in the assumptions on units (for reasons outlined above). However, there are some omissions which in total make a 14 unit net increase to the overall housing supply. An update to the trajectory has been submitted to reflect this.
4. On the basis of this assessment the Council maintains that the revised trajectory is sound and points of difference between calculation and assessment still stand.
