

# Notice of ground investigation works

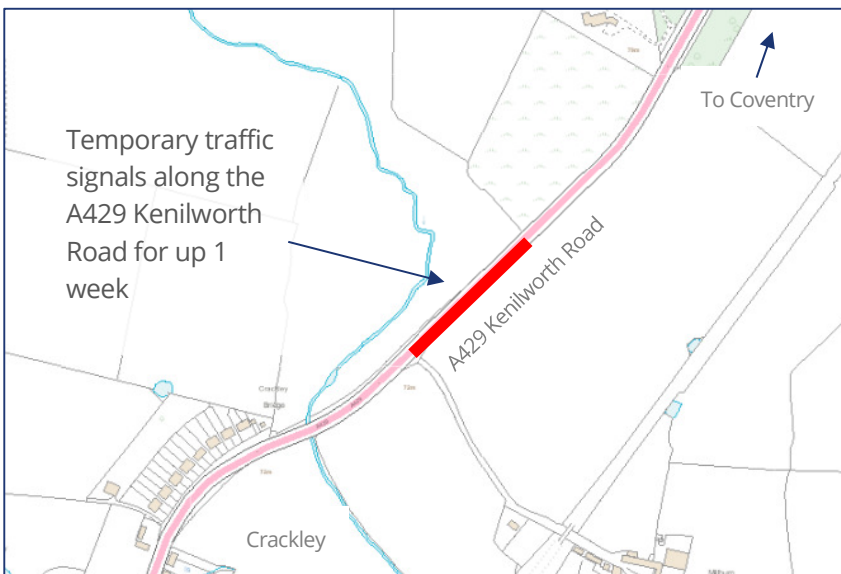

High Speed Two (HS2) is the new high speed railway for Britain which will provide a vital transport link for the country. Initial works on Phase One of HS2, from London to the West Midlands, have now started. These early works are carried out by LM – a joint venture between Laing O’Rourke and J. Murphy & Sons.

We will be in your area to carry out ground investigation works. These surveys will allow us to identify utilities located along a short section of the **A429 Kenilworth Road**. These surveys will be carried from **Wednesday 6<sup>th</sup> February and are expected to take up to 1 week**, subject to permits and site conditions.

Controlled temporary traffic restrictions using portable traffic signals will be in place on each day from 9.30am, with restrictions lifted and the road fully re-opened by 3.30pm.

From 6<sup>th</sup> February for up 1 week.
