

Temporary traffic lights on Long Itchington Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.


LM will be using two-way traffic lights on Long Itchington Road in Offchurch (on the National Cycle Route 41) to create a safe zone for accessing our HS2 worksite off the nearby Fosse Way (B4455).

The traffic lights will be in place for around six weeks (subject to site and weather conditions), in the area shown on the below map. The lights will be in operation during our working hours, and will be lifted from the road when we're not at work.

Long Itchington Road will not be closed – it will remain open – with traffic signals guiding cars through this section of the road.

Lights and signs along the road will help us enter and exit the area coloured orange on the map, enabling construction of a new access point for a proposed HS2 compound. In future, the compound will support the safe delivery of early and main works for the railway.

We will be at work on the road from Monday 22 July.

Our working hours will be between 8.00am and 6.00pm on weekdays, and between 8.00am and 1.00pm on Saturdays.

We might be on site for up to one hour before or after to set up or pack up.

Potential traffic delays on the road during peak times.
