

# Vegetation clearance near Stoneleigh Park

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

## Clearance may require temporary traffic lights

From mid-August through to September, we will be setting up temporary traffic management at various times to assist with safe vegetation removal along the Warwick Bypass (A46), near Stoneleigh Park, and on the B4115.

This may include temporary lane closures and/or traffic signals in the areas marked on the map on the next page. Our works have been designed to minimise disruption and maximise safety. Traffic signals could be in operation Monday to Friday, from 9am to 3pm and/or 10pm to 6am. Some weekend work may also be required, with temporary traffic management in operation from 6am to 6pm.

Traffic lights will be lifted from the road when we're not at work.

Our teams may be on site up to one hour before and one hour after the working hours to set up and secure sites each day.

## Why we're clearing in this area

Vegetation clearance on the A46 and B4115 will help us create an access point for a future compound in this area. The compound will support the safe construction of HS2 and realignment of the A46, needed to build the new railway.

## **Duration of work**

From the week commencing 5 August to late September 2019.

Our working hours will be Monday to Friday between 8am and 5pm and/or between 10pm and 6am. Some Saturday and Sunday working may also be required.

## What to expect

There will be temporary traffic management in the area as required to ensure safety.

There will be some low-level noise created by the works.

## What we will do

Keep all sites safe and secure.

Ensure all traffic management and diversions are clearly signed and marked.

Maintain access to properties.


## **Location of traffic management**

## Community funding opportunities

HS2 offers two funds that are available to local communities and businesses in the West Midlands, to help leave a lasting positive legacy in areas near the new railway.

These are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). A combined total of £40 million has been made available for both the CEF and BLEF for Phase One of the construction of HS2. The Funds will provide support for good quality bids, and funding will be available throughout this time period.

CEF and BLEF have supported 62 projects since March 2017, from small scale grassroots projects to large scale capital projects which benefit a wide range of communities.

## **Community and Environment Fund**

The CEF is designed to give communities the opportunity to share in the benefits of HS2. Community groups can apply for a CEF grant to support projects that aim to improve their local area.

## **Business and Local Economy Fund**

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local authorities; groups that support local businesses; business chambers; and similar organisations to help them maintain business activity in local communities.

## Recent grants in your area

- Kenilworth Town Council received £74,000 of BLEF funding for their 'Kenilworth is Open for Business' project to promote the local area and support local businesses during HS2 construction.
- Empowr-U, a Community Interest Company based in Coventry, received £75,000 from CEF to deliver the 'Own-It' project with children and young people aged 7–21 years living in Tile Hill, Canley, Kenilworth and Burton Green over the next two years.
- Long Itchington Parish Council received £74,500 to improve facilities at Long Itchington Park, including refurbishing play areas, toilets and a meeting place for parents and carers.

Administration of these funds is managed independently on behalf of HS2 by the charity Groundwork.
