


Temporary traffic lights – Burton Green

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

LM will be carrying out works to create two temporary accesses to facilitate the construction of the approved Kenilworth Greenway diversion in Burton Green. From **Monday 2**nd **December,** three-way temporary traffic lights with a lane closure will be put in place on **Hob Lane** (see map below).

Following works on Hob Lane, two-way traffic lights with a lane closure will be put onto **Red Lane** (see map below) to create a second construction access point starting around the **second week of December**, with works being completed before the Christmas break. All **traffic management will be on 24 hours a day, seven days a week with working hours 8am to 6pm to ensure safety during these works.**

Traffic signals on 24 hours a day, seven days a week for the duration of the works starting 2 December for up to four weeks, subject to site conditions.
