Acting under the powers delegated to me by Warwick District Council, I have considered your application received on the 20 January, 2020, requesting permission to carry out works to trees protected by Tree Preservation Order 543 at Riverside House, Milverton Hill, Leamington Spa, CV32 5HZ and I hereby give you notice that consent is GRANTED for the following work to be undertaken:

T34 x Acer platanoides - Remove deadwood, major only, over car parking G1 (0Z2A) x Acer platanoides - Fell at ground level T13 x Aesculus hippocastanum 'Baumannii' -Tidy stubs T36 x Cedrus deodara -Reduce split limb by 2m T27 x Cedrus deodara -Remove 1x broken branch and 1x split branch T11 x Cedrus deodara - Remove 1x broken branch T19 x Fraxinus excelsior - Remove 1x damaged and 1x broken branch T25 x Cedrus deodara - Remove 1x split and 1x hanging branch T26 x Cedrus deodara -Remove 2x detached branches and remove deadwood, major only T3 x Robina pseudoacacia - Crown reduce by 1.5m, north side T22 x Tilia platyphyllos -Tidy stubs G1 (185G) x Tilia x europaea - Remove basal/sucker growth and remove deadwood 25mm dia. & above G1 (185J) x Tilia x europaea - Sever and remove Ivy, remove deadwood 25mm dia. & above T12 x Tilia x europaea - Tidy stubs T16 x Tilia x europaea - Further reduction to original pollard points, remove deadwood and sever and remove Ivy G1 (188P) x Tilia x europaea - Sever Ivy and clear stem to 1m

Unless otherwise stated in conditions, the work granted by this notice must be carried out within two years of the date of this notice and may only be carried out once.

Subject to the following condition(s):

1 The works hereby permitted shall only be carried out in strict accordance with British Standard BS3998:2010 – Tree work – Recommendations or any equivalent standard. **REASON**: To ensure that the work is undertaken to an acceptable level of competence in the interests of the vitality and viability of the tree(s) in accordance with Policy NE4 of the Warwick District Local Plan 2011-2029.

Informative Notes

- 1 Many trees contain wildlife such as bats and nesting birds that are protected by law. The consent given by this notice does not override the protection afforded to these species and their habitats. You must take steps to ensure that the work you are carrying out will not harm any protected species, and if it may do so you must also obtain permission from Natural England prior to carrying out the work.
