

**THE WARWICK DISTRICT COUNCIL (LEPER HOSPITAL SITE, SALTISFORD,  
WARWICK) COMPULSORY PURCHASE ORDER 2021**

**THE TOWN AND COUNTRY PLANNING ACT 1990**

**AND THE ACQUISITION OF LAND ACT 1981**

The Warwick District Council, (in this order called the acquiring authority) makes the following order:

1. Subject to the provisions of this order the acquiring authority is under section 226(1)(a) and 226(3)(a) of the Town and Country Planning Act 1990 (as amended) hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of:
  - (a) Facilitating the development, redevelopment or improvement of land at the Leper Hospital Site, Saltisford, Warwick consisting of the conversion of two listed buildings into affordable housing and the construction of 8-10 affordable homes which is likely to contribute to the achievement of the promotion or improvement of the economic, social or environmental well-being of the acquiring authority's area; and;-
  - (b) Executing works to facilitate the development or use of the land.
  
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Site Location Plan (the Order Map) referred to in the Warwick District Council (Leper Hospital Site, Saltisford, Warwick) Compulsory Purchase Order 2021".

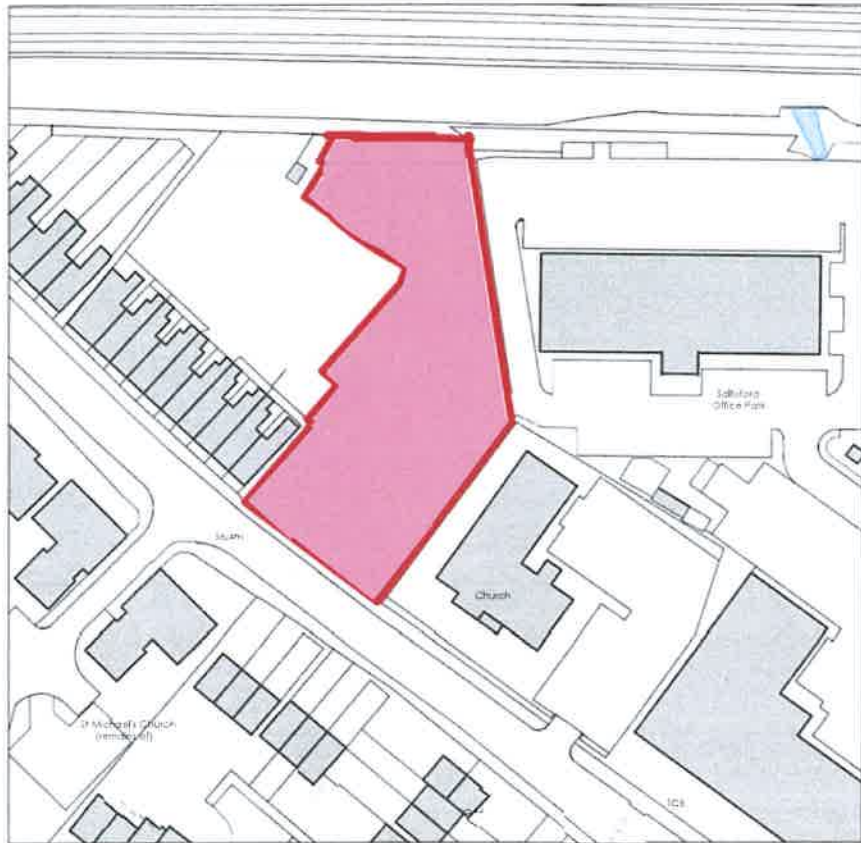
