
A message from

Dear Resident

The money needed to pay for the community facilities and local services we enjoy each year, comes from Council Tax, Business Rates, government grants and income



Warwick District receives less than 9% of the Council Tax collected and I am proud that this year its share has been frozen, without cutting services. In 2022/23, a band D household will continue to pay £176.86 in Council Tax, the same amount as last year. This equates to £3.40 per week for Warwick District Council services, such as waste and recycling collections, street cleaning, maintenance of parks and public spaces, environmental health, licensing, planning and community protection.

Warwickshire County Council, Warwickshire Police and many town / parish councils are increasing their tax again this year, so while Warwick District Council's share is frozen, we will still see an increase in our total bill.

The pandemic continues to have a significant impact on all our finances. Setting this budget has presented some tough challenges, and I'm especially pleased that we've been able to provide for an excellent level of service, while also continuing active support for our communities and maintaining an ambitious recovery programme.

Freezing our Council Tax is just one of a number of measures we're taking to address the financial squeeze many of us will experience over the year ahead. Thankfully, our partnership with Stratford on Avon District Council, and the efficiencies this is already generating, is helping us strengthen our services and share the financial benefits directly with our residents.

What is the Council Tax?

Each year the Government expects local authorities to raise money to help pay for the cost of providing local services. Some of this money comes from residents of the District and is collected by the Council in the form of Council Tax. Your Council Tax bill is based upon your Council Tax banding figure (which relates to the capital value of your property in 1991).

The District Council also collects Council Tax on behalf of the County Council, Police, Town and Parish Councils. Your Council Tax bill includes the charges from these authorities as well as that from Warwick District Council.


Why do you have to pay it?

By law we have to ask you for money and, by law, you are expected to pay. Failing to pay on time costs the council thousands of pounds each year, which can have an adverse effect on the following year's bills. In addition, failing to pay on time may result in additional costs being charged to you. We try to make paying the bill as easy as possible. We offer a number of ways in which you can pay. These are outlined on your Council Tax bill. There may also be help available (Council Tax Support) if you are on a low or fixed income.

Where does the money go to?

The money we collect from you is not all for Warwick District Council. In fact we keep just under 9p in every pound.

The rest of the money is collected on behalf of Warwickshire County Council, Warwickshire Police & Crime Commissioner and the local Parish and Town Councils. This part of the booklet tries to explain how the District Council's element of the Council Tax has been arrived at. How do we work out the Warwick District Council share of the Council Tax?

To work out the District Council element of the Council Tax we estimate what we will spend on delivering local services; we then reduce this for any income that we receive specifically for those services by way of fees and charges. This produces the Council's budget requirement. We then take away the money we will receive from the Government and from the Business Rates Pool. The balance is what is due to be raised from the Council Tax.

Calculating the Total Council Tax

£10m is the amount we need to collect in Council Tax to provide Warwick District Council services. We add on to this the amounts that the County Council, Police & Crime Commissioner and Parish/Town Councils require to provide their services, which we then collect on their behalf. In order to work out the specific level of Council Tax, these figures are divided by the number of properties in the area that are equivalent to a Band 'D'. For Warwick District in 2022/23 the total 'Band D equivalent' properties is 56,400.

The Band D 'average' for the District Council's share is just £14.74 per month when spread over 12 months.

Important Information

From 1 April 2021, the charge for empty domestic properties has been amended by the Council. A property that has been unoccupied and substantially unfurnished for more than 24 months will be charged 100% empty property charge and 100% empty property premium, meaning the total charge payable is 200% Council Tax. A property that has been unoccupied and substantially unfurnished for more than 60 months will be charged 100% empty property charge and 200% empty property premium, meaning the total charge payable is 300% Council Tax. A property that has been unoccupied and substantially unfurnished for more than 120 months will be charged 100% empty property charge and 300% empty property premium, meaning the total charge payable is 400% Council Tax.

In April 2022 the Government is providing a £150 one-off Energy Bills Rebate for most households in council tax bands A-D.

Warwick District Council and Fraud

We are committed to do everything we reasonably can to protect public money from fraud and, to this end, we may share information provided to us with other bodies responsible for auditing and administering public funds.
