

# **LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007**

## **The Warwick District Council (Reorganisation of Community Governance) Order 2019**

Made on 7<sup>th</sup> January 2019

Coming into force in accordance with article 1(2) on 1 April 2019

Warwick District Council ("the council"), in accordance with section 82(a) of the Local Government and Public Involvement in Health Act 2007(e) ("the 2007 Act"), has undertaken a community governance review and made recommendations dated October 2018:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section

The council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

### **Citation and commencement**

1. This Order may be cited as the Warwick District Council (Reorganisation of Community Governance) Order 2019. It shall come into force on 1st April 2019

### **Interpretation**

2. In this Order—

"District" means the District of Warwick;

"map" means the maps marked "Map referred to in the Warwick (Reorganisation of Community Governance) Order 2019" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983; and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8(c) of the Representation of the People Act 1983.

### **Effect of Order**

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

### **Elections for the parishes**

4. The elections of all parish councillors for the Parish of Norton Lindsey, Kenilworth Town, Royal Leamington Spa Town and Whitnash Town shall be held on the ordinary day of election of councillors in 2019.

### **Number of parish councillors for the parish of Norton Lindsey**

5. The number of councillors to be elected for the parish of Norton Lindsey shall be 7 (seven)

## **Wards of the parish of Kenilworth and numbers of parish councillors**

**6.**

- (1) The existing wards of St John's and Park Hill of the parish of Kenilworth shall be abolished.
- (2) These parish areas shall be divided into 4 wards which shall be named John's Ward, Borrowell Ward, Park Hill Ward and Dalehouse Ward (as set out on Plan ??).
- (3) Each ward shall comprise the area designated on the map by reference to the name of the ward and demarcated by orange lines.
- (4) The number of councillors to be elected for each ward shall be John's Ward (4 Councillors), Borrowell Ward (3 Councillors), Park Hill Ward (4 Councillors) and Dalehouse Ward (4 Councillors)

## **Alteration of parish areas of Royal Leamington Spa and Whitnash**

- 7.** The area coloured and designated by the letter "A" on the map shall cease to be part of the parish of Royal Leamington Spa and Willes ward of that parish and shall become part of the parish of Whitnash and East ward of that parish.

## **Electoral register**

- 8.** The registration officer for the District shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

## **Order date**

- 9.** The first of April 2019 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

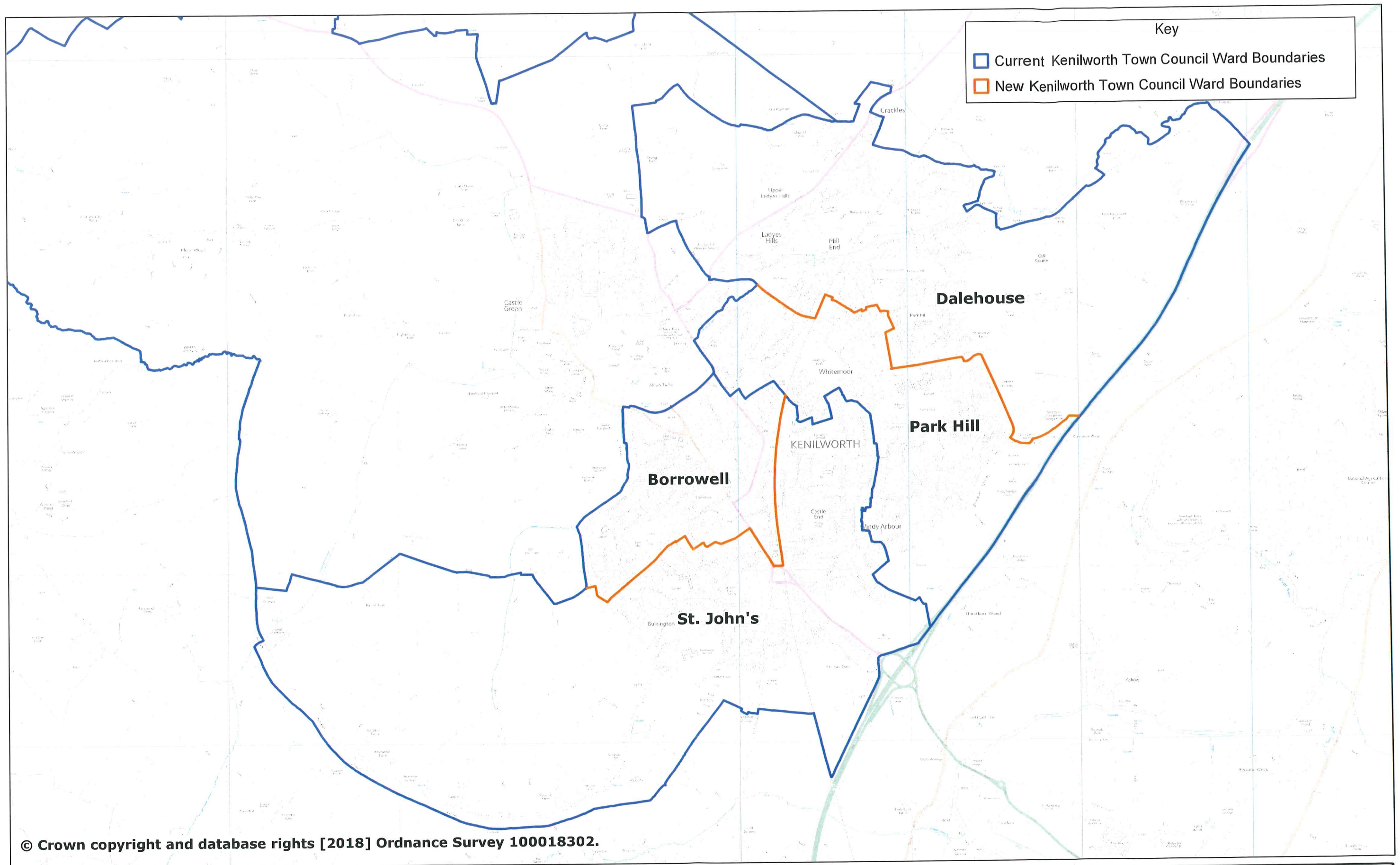


## **Reasons for making the Warwick District Council (Reorganisation of Community Governance) Order 2019**

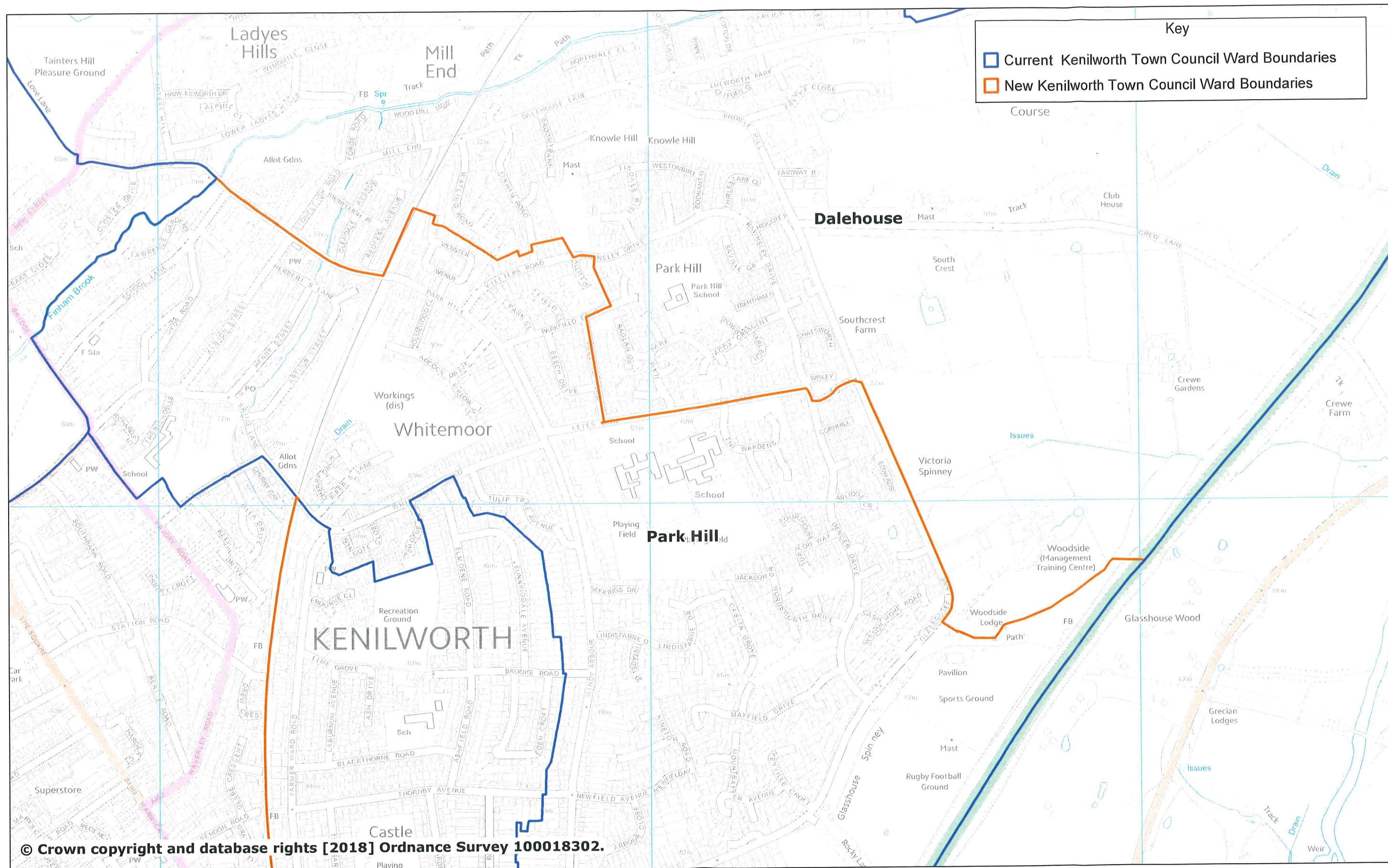
In the Community Governance Order Warwick District Council has made the following changes:

- (i) Amending the boundary of Whitnash and Royal Leamington Spa that runs through Campion School;
  - (ii) Subdividing the Kenilworth Town Council Wards of St John's and Park Hill; and
  - (iii) To increase the size of Norton Lindsey Parish Council from five to seven Councillors.
- 
- (i) As part of the review of Warwick District Council Ward Boundaries it was identified that the boundary between Whitnash and Royal Leamington Spa runs through the Campion School site. The amendment was made so that the Boundary follows the rear of the superstore, up to the roundabout on Chesterton Drive then meets the boundary on the middle of the railway bridge, thus providing a clearly definable boundary. Only one house is affected and would move from Leamington to Whitnash and there were no objections to the proposal, or alternatives proposed, during the consultation.
  - (ii) During the revisions to the District Council Ward Boundaries Kenilworth Town Council had concerns regarding the potential large Town Council wards proposed for Park Hill and St John's. This was because the wards would be represented by 7 and 8 Councillors respectively which was considered too great in number to enable effective representation at a Town Council level. Therefore the Town Council brought forward proposals to subdivide the proposed Wards. Public consultation was undertaken to which no responses were received and therefore it was considered reasonable to confirm the order.
  - (iii) Norton Lindsey Parish Council had requested to increase the size of the Council from 5 to 7 Councillors which would reflect the moderate growth in the Parish and also reduced the risk of Council meetings being in quorate.



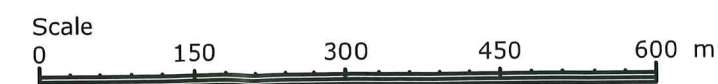
