Notes to this report:

This is the latest in a series of quarterly reports produced for the South Warwickshire Community Safety Partnership, providing an overview of recorded crime and disorder data.

Included in this report is data obtained from partners relating to the South Warwickshire Priorities for 2021-2025, as shown in the graphic on this page.

Comparisons to last year are included in this report following the colour coding method of:

Green = greater than 5% reduction

Amber = within +/-5%

Red = greater than 5% increase

It must be noted that the worldwide COVID-19 pandemic and consequent lockdowns occurred throughout 2020/21 and as such any trends including this time period must take into account irregular trends during this time.



Overall, violence related offences are level with volumes seen last year in both districts and this has been the trend throughout the financial year. At year end, violence with injury offences are higher than last year in Warwick District (+6.5%) and have not reduced in this latest quarter which is in contrast to seasonal trends. This is in part due to an increase in domestic related violence (see right).

Night-Time Economy* - violence involving alcohol is at much lower volumes than last year across both districts. Over a third of all violent offences in both districts occurred in a public place this quarter. This is slightly above last quarter. The most affected public place location types continue to be on the **street** (14%), in **a licensed premises** (4%) and in **schools/colleges** (4%).


Domestic related Violence

Volumes of domestic related violence with injury offences are showing higher volumes compared to last year. Both South Warwickshire Districts are showing increases compared to quarter 4 last year. This is also reflected in referrals to Refuge (9.6% increase in Stratford and 5.9% increase in Warwick) and in high and medium risk DARAs.



Volumes of reported rape offences reported this year are higher in Warwick (+8.1%) and lower in Stratford District (-7.0%) than last year. However, other sexual offences reported to Warwickshire Police are higher than last year across both districts.

20% of **rape and other sexual offences** in South Warwickshire this quarter were domestic related which is similar to the previous quarter. For rape offences this figure is almost half (46%), whereas for other sexual offences it is 10%.

Around a quarter of offences reported this quarter occurred prior to 2024 (25%), this rises to 40% for rape offences (19% for other sexual offences).

Rural Domestic Violence (Stratford-on-Avon District):

The Warwickshire Serious Violence Prevention Needs Assessment highlighted a possible trend in unreported **domestic violence in rural locations in Stratford-on-Avon District**. This was due to 63% of domestic violence reports from the district occurring in rural locations compared to 76% of the district being rural.

With the rural urban classifications now being available for 2021 LSOAs, domestic violence for the year 2024/25 for Stratford District has been calculated. This has shown that 65% of domestic violence occurred in rural locations and 35% in urban locations. Whereas 73% of the population aged 16+ live in rural locations and 27% live in urban locations. Therefore the rate of domestic violence for those living in a rural location is 7.6 per 1,000 population aged 16+, whereas it is 11.1 per 1,000 population aged 16+ for those living in urban locations. This suggests that DV is still under reported in rural areas and there could be further in depth analysis into this now that the rural / urban classifications have been updated by the ONS.

The top rural LSOAs with 25 or more offences in the year were:

Bidford East, Waterloo and Broom - 26 Deppers Bridge, Chester & Kings - 26 Alcester North & Conway - 25 Ettington – 25

It is recommended that the CSP analysts conduct further in depth analysis into domestic violence in rural locations in Stratford District.



Volumes of residential burglary dwelling offences are higher than last year, although this increase is due to increases in **Stratford-on-Avon District** (+20.4%). In **Warwick District**, offences have reduced by 8.1%.

However this quarter offences were spread across the two districts, with locations with the highest volumes shown on the map.

Personal Robbery

Personal Robbery Offences have reduced in Stratford-on-Avon District and increased in Warwick District this year. Four of the offences involved a knife (slightly lower volumes than Q4 last year) and these were mainly in Warwick District in a public place (3 offences).

Vehicle Crime



Volumes of **vehicle crime** are much lower than last year in both districts. Offences have increased slightly in **Warwick District** during this latest quarter compared to quarter 3.

There were fewer repeat locations this quarter, with 6 offences at the **M40 services** (a reduction from 20 in the previous quarter)

Rural Crime – Offences recorded as part of the Rural and Wildlife Crime Strategy continue to be higher than last year in South Warwickshire. However, much of this increase is due to **Op Snap reports** now being included in the data. This relates to all incidents involving equine and livestock on roads, with around 40% of the reports this year in South Warwickshire relating to these incidents. 70% of rural crime this year in South Warwickshire has occurred in **Stratford-on-Avon District**.



Knife related violence – Offence volumes are much lower than last year in both districts. Around two thirds of the knife related violence offences this quarter occurred in a private dwelling (13 of 19 offences) and nearly half of the offences were domestic violence related (8).

Possession of weapons offences are lower than last year in both districts. Offence volumes were higher in **Warwick District** this quarter (36 offences) and town centres continue to be the main hotspots across South Warwickshire. Just over half of the offences across South Warwickshire this quarter involved a knife, including machetes (58%, 34 offences, 4 of which were machetes). Other weapons noted include firearms (6), and hammers (4).



Substance Misuse - Possession of drugs offences this year to date are higher than last year in both districts, however there has been a bigger increase in Warwick District (61.7% compared to 6.8% in Stratford on Avon District). In contrast, volumes of trafficking offences are lower than last year.

Referrals to **CGL** from **Stratford on Avon District** have increased compared to last year, and this is due to increased referrals for alcohol. Referrals from **Warwick District** have reduced slightly overall, however there has been a slight increase in those relating to 'cocaine-unspecified'.

Exploitation – Offences relating to child sexual exploitation in South Warwickshire continue to be much higher than last year (66 offences for the year, +50%) although this is a countywide trend and is likely to be due to improved processes and identification of vulnerable victims. In comparison, referrals to **Family Connect (Previously Childrens and Families Front Door)** this year for **South Warwickshire** have slightly reduced compared to last year across both districts (-196 referrals to 1,781 referrals for the year, this is lower than the previous 4 years). **Return Home Interviews** following a missing episode have however increased from Q3 to Q4 in both districts (longer term trend data not available).

Persistent absence and exclusion rates will be analysed when there is more data available for the 2024/25 academic year.



Performance - South Warwickshire CSP Priority - 6) Personal ASB in Stratford-on-Avon District



Personal ASB in Stratford-on-Avon District – Reports of personal ASB in the district continue to be much higher than in previous years, as shown on the graph, being 40.8% higher than 2023/24. The reasons for the countywide trend of high volumes of personal ASB incidents is not clear, with analysis by the police proving inconclusive. There is some suggestion that a revised Police Force ASB policy placing a focus on resourcing personal ASB may be a contributing factor. In addition, continued targeted patrolling as part of Op Resolve may also contribute to increased identification of ASB. Analysis as part of the Strategic Assessment process has also identified higher volumes of this type of ASB in Stratford-on-Avon District due to long-term current personal ASB issues with repeat victims.

It is recommended that the CSP continue to liaise with the Op Resolve team to identify any prevention opportunities.

Volumes of reported **Cyber Fraud** offences remain lower than last year in both districts, at 79 offences for the year, compared to 116 in 2023/24.



Hate Crime – At year end, volumes of reports to police have returned to more typical levels after the peak in the summer months and are at lower levels than in 2023/24. However, volumes of reports have reduced more in Stratford-on-Avon District than Warwick District.

Volumes of reports to Equip, Victim support and Schools Prejudice related incidents have not seen reductions and have remained at similar levels. When including reports to all organisations, Stratford-on-Avon District has seen an increase in hate crime related to sexual orientation, and Warwick District has seen an increase in hate crime related to race.

Please note, the chart above includes reports to all partnership agencies not just the police. Therefore, the volumes in the chart will be larger than the overall reported offences. Please see the Warwickshire Hate crime Dashboard for more information.

Summary of Key Findings – Quarter 4 24/25:

- Overall, violence related offences are level with volumes seen last year in both districts and this has been the trend throughout the financial year, however violence with injury offences have ended the year higher than last year in Warwick District.
- Volumes of domestic related violence with injury offences are showing higher volumes compared to last year. Both South Warwickshire Districts are showing increases compared to quarter 4 last year.

Business Intelligence

It is recommended that the CSP analysts conduct further in depth analysis into domestic violence in rural locations in Stratford District.

- Volumes of reported rape offences reported this year are higher in Warwick (+8.1%) and lower in Stratford District (-7.0%) than last year. However, other sexual offences reported to Warwickshire Police are higher than last year across both districts.
- Volumes of residential burglary dwelling offences are higher than last year, although this increase is due to increases in Stratford-on-Avon District (+20.4%). In Warwick **District,** offences have reduced by 8.1%.

It is recommended that the CSP continue to liaise with the Op Resolve team to identify any prevention opportunities.

• Volumes of hate crime reports have ended the year at lower levels than in 2023/24, although have reduced more in Stratford-on-Avon District than Warwick District.
